

The Bill of Rights

Ratified December 15, 1791

Article I

Congress shall make so law respecting an establishment of religion; or probability the free exercise thereof; or abridging the freedom of speech, or of the press; or the right of the chaple percentily to assemble, and to pention the Government for a redress of grievances.

Article II

A well regulated Militia, being necessary to the security of a free Sente, the right of the people to keep and bear Arms, shall not be intringed.

Article III

No Soldier shall, in time of peace be quartered in any bouse, without the connent of the Owner, nor in time of war, but in a manner to be prescribed by law.

Article TV

The right of the georgie to be secure in their persons, houses, paper, includings, against unremonable searches and searches, shall not be violated, and no Warrants shall issue, but upon probable cause, supported by Oath or affirmation, and particularly describing the place to be searched, and the persons or things to be search.

Article V

No person shall be held to answer for a capital, or otherwise infamous crime, unless on a presentment or indistinguish of a Grand Jury, except in cases aroning in the limit of naval forces, or in the Millian, when in actual service in since of War or public danger, nor shall any person be subject for the same offence to be fix ice purin jeopardy of life or limb; nor shall be compelled in any Criminal Case to be a winger against himself, nor be deprived of life, /merry, or property, without due process of law; nor shall private property be taken for publicure, without just compensation.

Article VI

In all criment prosecutions, the accused shall enjoy the right to a speedy and public trial, by an impartial jury of the State and district wherein the crime shall have been committed, which district shall have been previously incertained by law, and to be informed of the nature and cause of the accusation; to be confronted with the witnesses against him; to have compulsory process for obtaining Witnesses in his favor, and to have the Assistance of Counsel for his defence.

Article VII

Bu Suica at common law, where the value in controversy shall exceed awency dullars, the right of trial by Jury shall be preserved, and no fact tried by a fury shall be otherwise recommend in any Count of the United Seates, than according to the guler of the common law.

Article VIII


Excessive buil shall not be required, nor excessive fines imposed, nor cruet and unusual pensishment inflicted.

Article X


The powers not delegated to the United Stateship the Constitution, nor probabilised by it to the School are reserved to the School respectively, or to the people.
