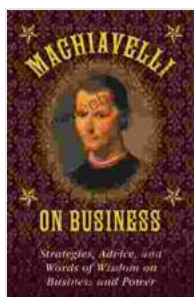

Cooperative	- Member-owned and controlled - Democratic decision-making - Shares profits with members	- Can be slow and bureaucratic - May be difficult to attract new members

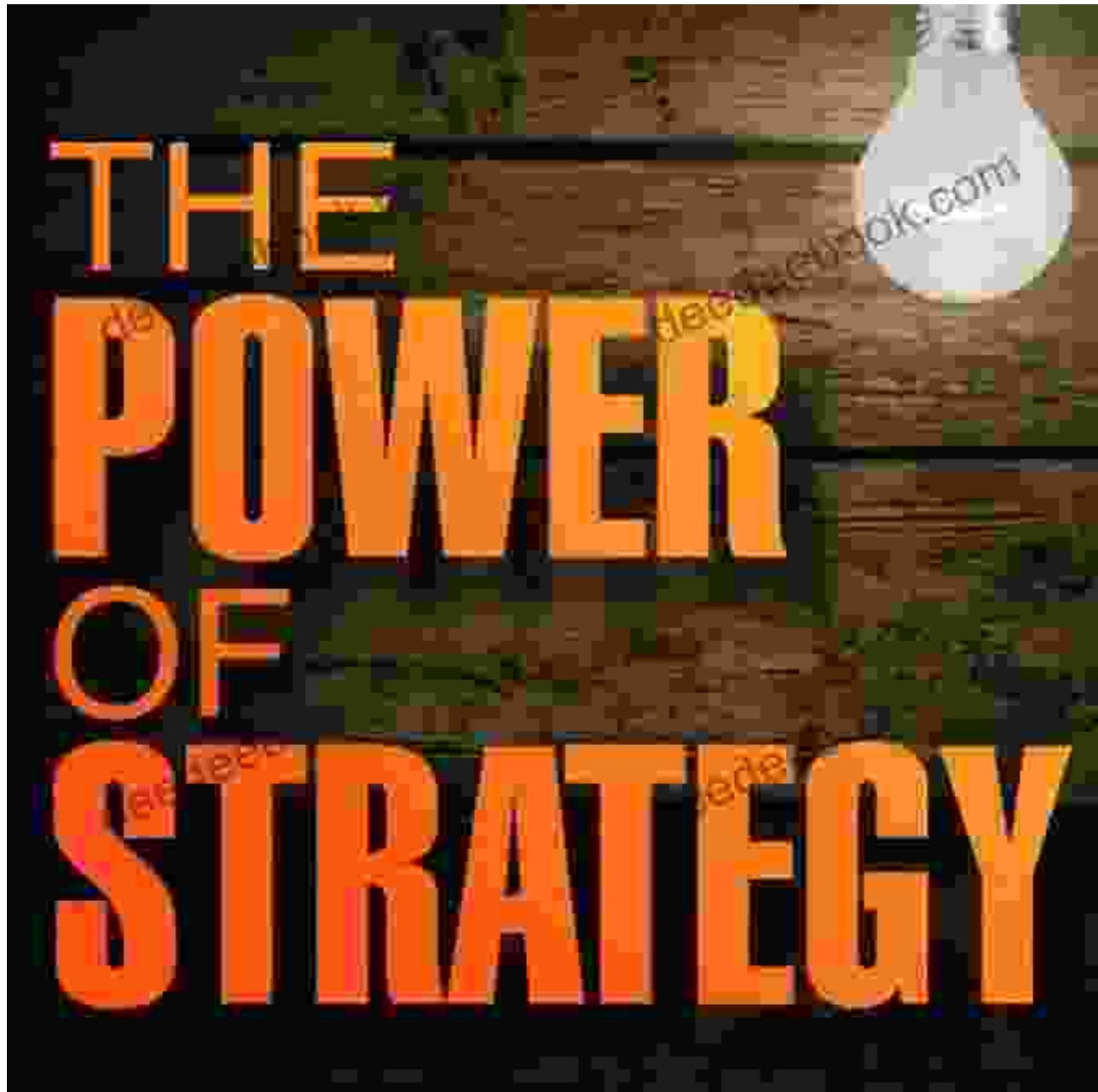
